GENERAL INFORMATIONS

The Pôle interordres de Montréal (PIM) is, in the beginning, an initiative of the CEGEPs and universities of Montreal supported by the Ministry de Higher Education with a view to providing a concerted response to the training challenges represented by developments in artificial intelligence. The PIM brings together the higher education institutions of Montreal, 12 CEGEPs and 7 universities.

Originally, the Pole aims to increase the capacity of CEGEPs and universities in Montreal to rapidly develop and adapt the training offer related to AI in collaboration with interested partners. However, in the fall 2021, the Ministry of Higher Education asks each “pole regional” to refocus activities based on ministerial objectives for success in higher education:

1. Promote accessibility for people in higher education, especially underrepresented groups (Aboriginal people, people with disabilities, first-generation students, people from disadvantaged backgrounds, immigrants, etc.).
2. Improve the fluidity of training courses and smooth, quality transitions in higher education.
3. Deploy practices and measures adapted to the needs of the student community in order to support it in its diversity.
4. Respond to national and regional training employment matching needs.
5. Promote the rapprochement of CEGEPs and universities with secondary education in order to attract young people, especially girls, to study programs related to information technologies.

The PIM retains, among other priorities, the first two objectives. It invites ecosystem players to develop projects lasting a minimum of one year and a maximum of two years in connection with these. **Proposals do not need to be linked to artificial intelligence.**

The PIM wishes to support five collaborative CEGEP / university projects to which it can allocate up to 80 000\$ per project at the rate of 40 000\$ paid respectively in May 2024 and May 2025.

WHO CAN SUBMIT A PROJECT?

A project must be submitted, in collaboration, by a team from at least one CEGEP and one university, both members of the PIM (the list of member institutions is in appendix 1).

The team proposing the project can join organizations external to the pole, other establishments, or companies. There is no limit to the number of partners.

Each project must have obtained the support of the management of the partner institutions. These methods are provided for in the proposal presentation form and specified in the rest of this guide.

THEMES AND EXPECTED RESULTS

The objective of this call for projects is the implementation of concerted inter-order projects combining CEGEPs and universities either in the form of an innovative initiative or the consolidation of existing activities to enrich them or create new collaborations. These projects will consist of either promoting accessibility to higher education or improving transitions from one level of education to another.

Accessibility to higher education refers to the fact of being admitted and starting studies at CEGEP or university. In its *Action Plan for Success in Higher Education 2021-2026*, the Ministry of Higher Education recognizes both the diversity of the student community and the under-representation of certain groups or social categories.

Once engaged in their studies at a new level of education, the student must adjust to their environment in its multiple dimensions. If this represents a challenge for him or her, it is also a challenge that engages the various actors in educational circles.

The projects that the PIM wishes to support must fall under one of these two themes.

THEMES	OBJECTIVES	ISSUES
Accessibility in higher education	Promote accessibility for people in higher education, especially underrepresented groups (Aboriginal people, people with disabilities, first-generation students, people from disadvantaged backgrounds, immigrants, etc.).	For many years, research has shown that certain social categories of people have difficulty accessing higher education, thus reinforcing inequality of opportunity. For example, gaps in CEGEP and university graduation rates persist between non-natives and First Nations; young people from disadvantaged backgrounds are more likely to lack support to navigate through the prerequisites and requirements of higher education; young people with disabilities in their first college session have more difficulty knowing whether they want to continue their education.
Harmonious transitions in higher transition	Improve the fluidity of training courses and smooth, quality transitions in higher education.	Students who experience a positive integration into their educational institution are more likely to succeed in their first term of college or first semester of university, a period known to promote long-term perseverance.

The Ministry also identifies outcome indicators for the activities implemented for the objectives of accessibility in higher education and harmonious transitions:

- The number of students from secondary schools affected.
- The number of college and/or university students affected.
- The number of participants concerned (other than students)
- The number of high schools reached or engaged.
- The number of organizations other than schools reached or engaged.

ELIGIBILITY REQUIREMENTS

Projects must be submitted using a form provided for this purpose.

To be eligible, the proposal must meet the following conditions:

- ◇ Involve members of at least one CEGEP and one university that is part of the Montreal Center for Higher Education in Artificial Intelligence (PIM).
- ◇ Designate a project manager institution.
- ◇ Have the support of the management of each partner educational institution in the project.
- ◇ Submit an allocation formula for the project that does not require a financial contribution of more than \$ 80,000 from the PIM.
- ◇ Before a minimum period of one year and a maximum of two years between the month of May 2024 and the end of June 2026
- ◇ Register under one of the two themes presented in the previous section.

EVALUATION CRITERIA

Any project proposal meeting the eligibility requirements described in the previous section will be subject to the evaluation of an independent jury and evaluated according to the following criteria:

RELEVANCE — 30%

- ◇ The needs, issues and innovative aspects of the project are clearly defined.
- ◇ The project contributes to consolidating the regional ecosystem of success in higher education.
- ◇ Results expected and the way to measure them are clearly described and take into consideration the outcome indicators as defined by the Ministry.
- ◇ The contribution of the project to the strengthening of equity, diversity and inclusion is clearly demonstrated.
- ◇ The project promotes concertation and collaboration between CEGEPs and universities.

QUALITY OF THE PROJECT — 40%

- ◇ The proposal is based on educational, scientific, or technological knowledge mastered by the members of the project team.
- ◇ Depending on the topic to deal with, the chosen approach is based on recognized practices or methods.
- ◇ The roles and responsibilities of the project team members and the project management methodology are well defined.
- ◇ If the project includes external collaborations, the contribution of these partners is well described, and a letter of commitment is appended to the file.
- ◇ The deliverables are verifiable, and the implementation schedule demonstrates the quality of the project planning.

PROJECT BENEFITS — 30%

- ◇ The benefits of the project for the partner establishments are clearly demonstrated.
- ◇ The proposal shows the benefits of success in higher education in Montreal.
- ◇ The proposal provides for a plan for the promotion, intervention, or dissemination of the deliverables in the networks of PIM establishments and beyond when relevant.

The jury will be made up of people appointed by the PIM steering committee. It will recommend the best projects to the PIM steering committee, which makes the final decision.

FUNDING

The PIM provides for a maximum funding of \$ 80,000 per project. Proposals must present an allocation formula that does not require a financial contribution greater than this amount for a period from spring 2024 to June 2026 at the latest.

An amount of \$ 40,000 will be paid to each of the projects accepted in the spring of 2023 for the purposes of starting the project. A second instalment of up to \$ 40,000 will be returned in May 2024.

PROJECT PRESENTATION

To submit a project, proposers must use a dedicated form downloadable from the PIM website: www.poleia.quebec.

APPENDIX 2 — DEFINITIONS

These definitions refer to certain terms used in the entry form.

MANAGER INSTITUTION	<i>The institution managing the project is the trustee of the PIM grant.</i>
CONTRIBUTORS	<i>Contributors shall be the individuals who carry out the project. They shall also take part in a community of practice activities and agree to present findings at an official PIM activity or event designated by PIM.</i>
EXTERNAL PARTNERS	<i>External partners shall be representatives from organizations and companies other than PIM's 19 member institutions (12 colleges and 7 universities).</i>
